8. Highways & Rights of Way

- The results of the traffic survey conducted in June 2025 are published on patney.net, and can be found here. The data is broadly similar to the survey conducted in 2024, and again falls below the required threshold for any further action by WC; the Combined 85th%ile Speed (mph) was recorded as 27.6mph, average speed approx. 22.5mph, and 6.1% of vehicles exceeding the 30mph limit
- The street lighting survey was conducted in July, which led to installation by WC of 4 double-sided speed limit repeater signs along Woodland Road
- No further action is currently planned, other than ongoing monitoring; a further traffic survey will be considered in 2026 to measure the impact of the speed limit repeater signs

9. Matters from the public

- The refurbishment of the telephone box on the village green was completed in August; thanks to Andy Sharp for undertaking this
- A replacement bench for the village green has been added to the 2025-26 budget, for installation early next year
- A poppy wreath has been purchased from RBLI for laying at the Chirton war memorial again this year
